

IT WORKS! "TOO GOOD" TERMS AND CONDITIONS

1. <u>Eligibility</u>: This Promotion is open to all It Works Marketing, Inc. ("It Works!") Distributors ("**Distributor**") who are active, and Commission qualified for October 2014. This Promotion is not available to members of the general public who are not It Works! distributors. This Promotion is internal, limited to It Works! **Distributors** only and who meet the following terms:

2. Timing and Terms:

- a. For every combination of distributor and Loyal Customer you enroll between October 1, 2014 and October 31, 2014 you will receive 1 entry into the Promotion. Examples: If you enroll one distributor and one Loyal Customer, you receive one entry. If you enroll 3 distributors and 3 Loyal Customers, 3 entries. If you enroll 3 distributors and 2 Loyal Customers, you will receive 2 entries. There is no cap on the number of entries you can earn. The more skillful you are at signing up distributors and Loyal Customers that purchase product, the greater the likelihood of winning.
- b. In November, we will draw 20 entry tickets. The 20 **Distributors** whose tickets are drawn will be entitled to have up to USD\$20,000 paid on the **Distributor's** existing credit card debt. Multiple credit cards of the **Distributor** can be combined, up to the \$20,000 limit.
- c. If the winning **Distributor** has no credit card debt, then up to USD\$20,000 can be applied to student loans or medical debt.
- d. The winners of this up to USD\$20,000 Promotion may only apply the proceeds to one category of debt. For example, assume **Distributor A** was chosen and has USD\$11,000 of credit card debt and USD\$9000 of medical debt. **Distributor A** would be entitled to receive USD\$11,000 to pay off her credit card debt.
- e. This is the priority for payment: 1. Credit card debt; 2. Student Loans; 3. Medical Bills.
- f. If a Distributor has no credit card debt, student loans or medical bills, then no gift will be awarded.
- g. For purposes of this Promotion, a **Distributor** and her/his spouse, whether personally or in a corporate capacity, count as one and may only win one time. Spouses may combine credit card debt up to the \$20,000 maximum. All debt must be personal debt in the name of the distributor or their spouse. This Promotion is intended for personal consumer debt only and is not intended to be used for business credit card purchases.
- h. Winning Distributors will receive their payment by January 1, 2015 as long as all conditions are met.
- i. For purposes of qualifying for this Promotion, the Loyal Customer must be placed under the qualifying **Distributor** and cannot be placed or moved under a different distributor.
- j. In order for the **Distributor** to receive the up to USD\$20,000 payment, all Loyal Customers used to qualify must complete the terms of the Loyal Customer Agreement.
- k. The up to \$20,000 cash payment applies to credit card debt, student loans, and medical bills, debt incurred prior to October 1, 2014.
- I. Winning distributors must submit a copy of the credit card bill or other proof of indebtedness and agree to be photographed or videotaped for promotional purposes.
- 3. Agreement to Official Rules: By participating in the Promotion, the Distributor fully and unconditionally agrees to and accepts these Official Rules and the decisions of It Works!, which are final and binding in all matters related to the Promotion.
